## WHAT'S NEW AT AGO?

### <u>New World Headquarters for AGO:</u>

AGO has moved to a new office, but no worries, we still have the same address and same quality service!



### **Policy:**

- Added Recently Viewed policy list when doing a selection or search, clicking on the link will go directly into the policy depending upon policy status and function initiated.
- New tool to allow an administrator to view active users.
- Amended History screen to add summary sections for Drivers and Vehicles to allow the user to see all drivers and vehicles on the policy at any point during the policy term, including when they were added and/or deleted from the policy.
- Enhanced "Save As" feature to allow the user to copy a Commercial Auto application to an Inland Marine or General Liability application. This saves the user from re-keying the application under a new line.

### <u>Claims:</u>

- When setting up a new diary, a calendar control can be opened to present the recipient adjuster's currently scheduled workload. This prevents over/under scheduling of adjuster work days.
- Revision to Claim Selection page to include a list of claims recently accessed by the user. Clicking on a claim number will proceed directly into that claim file. By clicking on the copy icon to the right of claim number, the **Company, Line of Business** and **Claim** fields are populated for use as a model when keying in the next claim request.
- Revision to Correspondence Page to add a 'PAY' column that is activated when the Document Category is 'Invoice' and the Status is set to 'Approved'. When clicked, the Payment Entry page appears and such a Payment Request and resulting check is linked with the correspondence. The user may view a received bill and easily see the satisfying payment.

When entering a payment request, choose the entity with the Tax ID as "Payee" (to ensure proper 1099 reporting). Then under "Addressee" do a separate search to select the entity with the mailing address where the check is to be sent.
